# White Coat ceremony: the rite of passage

On Saturday, March 18, 97 members of the Cornell University College of Veterinary Medicine Class of 2018 participated in the White Coat ceremony, a rite of passage for third-year veterinary students. The students were coated by their chosen mentors—veterinary faculty members or DVMs who made an impact on their pre-clinical study. They also all stood and recited the veterinarian's oath, administered by Dr. Susan Ackerman, DVM '86, chair of the Alumni Association Executive Board.

The ceremony provides students a symbolic transition from the pre-clinical to the clinical phase of veterinary education. The white coat is a symbol of medical professionalism and the ceremony signifies the beginning of students' clinical apprenticeship to sustain and restore the health of animals and people.

Lorin D. Warnick, Austin O. Hooey Dean of the College of Veterinary Medicine, spoke of the great responsibility of donning the white coat (or coveralls and boots) as they start clinics: "Your responsibilities for client communication and patient care increase. Having completed all your pre-clinical course work, you are in a better position to integrate the knowledge and skills you have learned and apply them in a clinical setting. You are taking another step in joining the veterinary profession and accepting the associated rights and responsibilities."

students to learn from their mistakes, follow their own path, and to be confident in their knowledge and abilities. These three "nuggets" of advice were delivered with humor, sincerity, and wit.

# **Phishing & Security**



Dear Colleagues,

Over the past several months, the University has experienced an alarming increase in the number and sophistication of fake emails designed to damage and/or gain access to Cornell systems. These well-written "phishes" have appeared to come from me, President Rawlings, deans, vice presidents, even the Cornell emergency alert system, and have successfully deceived some faculty and staff into revealing their NetID passwords.

To address these threats and provide better protection against fraud, financial loss, and identity theft, Cornell is adopting Two-Step Login. I urge you to take an important step to better protect your personal Cornell information, as well as the integrity of our institutional data, by enrolling in the Two-Step Login service as directed below. This is the same technology many of us use for online banking and purchases, and will be required beginning April 20 for all Workday functions (tax forms, direct deposit, changes to dependents, employment verifications, etc.).

I have enrolled and found the process straightforward and the system easy to use. If you are not among the third of Cornell faculty and staff who have already enrolled, please do so as soon as possible. Also strongly consider choosing the option to expand Two-Step Login so that your NetID password will be protected with most university services: <a href="https://it.cornell.edu/twostep/expand/">https://it.cornell.edu/twostep/expand/</a> (https://it.cornell.edu/twostep/expand/).

#### Two-Step Login for Workday

Beginning April 20, 2017, the university will require Two-Step Login to access your most sensitive data in Workday:

- Tax forms
- · Payment elections (direct deposit)
- Address changes
- · Changes to dependents
- I-9 (Employment Eligibility Verification form)

Requiring Two-Step Login for this handful of high-risk Workday tasks will provide an immediate, large security benefit for the Cornell community, without imposing a significant change in the daily activities of faculty, staff, and student employees.

Would you know what to do if your pet suddenly collapses? One of the great benefits of working at the College of Veterinary Medicine is being surrounded by experts in so many different fields. Dr. Daniel Fletcher recently presented a lecture/webinar on the basics of cardiopulmonary resuscitation (CPR). The event was co-sponsored by The Baker Institute for Animal Health and the Cornell Feline Health Center.

Dr. Fletcher explains how to check your pet's airway and demonstrates how to perform chest compressions and mouth-to-snout ventilation. Attendees were able to practice on specially designed mannequin cats and dogs.

Dr. Fletcher is Cornell University College of Veterinary Medicine's Associate Professor of Emergency and Critical Care and co-chair of the RECOVER Initiative, which published the first evidence-based veterinary CPR guidelines in 2012. He has taught CPR courses all over the world.

### What's happening and what's ahead?

Construction

- Construction for new Library/MRC/Dean's Suite wing continues. Interior framing and infrastructure installations continue. Scheduled for completion August 2017.
- Construction of the new cafeteria continues. Interior framing and infrastructure installations continue. Scheduled for completion August 2017.
- New Atrium and lecture hall building is enclosed. Interior framing, infrastructure installations continue.
- Some temporary walls will be constructed in the Schurman tutorial corridors.
- Schurman roof replacement demolition has started.
- Glass curtain wall is being installed on new Library wing and courtyard side of New Atrium.
- Site work for central courtyard started. Installation of exterior stairs to start soon.


