Explanation: The facility does not have a union, but workers representatives elected by workers have formed committees like Works committee, H&S committee and anti-sexual harassment committee. The works committee addresses grievance issues, but is not a forum for collective bargaining of wages and benefits.

Plan Of Action: Hanesbrands' Global Standards for Suppliers state that facilities shall respect the right of workers to freely associate and collectively bargain, and we expect factories to abide by this.

Supplier CAP: The collective bargaining of wages and benefits are being discussed in meetings from now on and the increment proposal is purely depends upon the performance surveyed by the higher officials and got approval and informed the same to workers at the time of meeting conducted.

posting of evacuation plans, the installation and maintenance of an employee alarm and emergency lighting systems, ensuring aisles/exits are not blocked and that workers are not blocked within their workstations, employee education, evacuation procedures, etc.) shall be complied with. Workers shall be trained in evacuation procedures. Alarm systems shall be regularly tested and evacuation drills shall be undertaken at least annually. (S)

Explanation: There are markings in all locations, but these have worn out over time. In addition, the direction of movement during an evacuation is not seen at any location - both of these issues were addressed overnight and found present on the second day of the audit. The exits are clearly marked and easily accessible. However, the aisles leading to these exits are not free.

Plan Of Action: Hanesbrands will perform a follow up visit to this factory regularly to ensure that the exits are clearly marked and easily accessible always. We will invite the factory compliance person to draw the plan to monitor these issues monthly.

Supplier CAP: Immediate action: Markings are arranged in all locations. In addition, the direction of movement during an evacuation is marked. The exits are clearly marked and easily accessible. Long term: Assign compliance person to monitor those 2 issues monthly and follow up with the related department to correct those issues if the marking is removed or peeled off from time.

All the production personnel are instructed by the management to keep the exit routes free in all working time. They also have rented a new shed for storage of cartons to ensure free exit routes.

Health and Safety: J. Safety Equipment and First Aid Training

H&S.10 All safety and medical equipment (such as fire fighting equipment, first aid kits, etc.) shall be available in sufficient numbers throughout the factory, maintained and stocked as prescribed and easily accessible to workers. A sufficient number of workers shall be trained in first aid and fire fighting techniques. (S)

Explanation: The fire extinguishers are in working order, but in fabric storage building,

the markings are not clear and they are not easily accessible since there are rolls of fabric blocking the approach. At the time of the audit some of the items were in short supply in the first aid boxes in production area. E.g. plaster, band aids, bandages. Regular stock replenishment was not in evidence. In contrast, some supplies stored are not appropriate to be stored in the first aid box. E.g. there is no need to stock anti-biotic eye/ear drops in the first aid box. No procedures were posted for first-aid.

Plan Of Action: Hanesbrands will monitor the factory to set up a system and assign factory staff to ensure that fire extinguishers are in workable condition; markings are kept clear; fabric rolls are kept in designated area; first aid boxes are stored proper and sufficient medicines. The follow up visit will be done in January.

Supplier CAP: 1. Assign staff to: Inspect fire extinguishers monthly to ensure in workable condition; Inspect the markings to be kept clear and the fabric rolls to be kept in the designated place. 2. A sufficient quantity of appropriate first aid articles will be stored in the first aid boxes. A check list for essential first aid items will be attached with all first aid boxes. Then, we will assign a staff to check the first aid items daily to ensure its sufficiency.

Action Taken: The Fire extinguishers are in working order in fabric storage building and the markings are cleared and those are now easily accessible and the fabric rolls are removed from the place of Fire extinguishers. The first aid boxes are provided with sufficient first aid medicines. The antibiotic eye/ear drops are removed from the first aid boxes. See photo attachment.

Hanesbrands auditor performed follow up visit on 2/26/2009: Having visited fabric storage area, newly leased and old finished carton storage area, no fire extinguishers have been installed. Factory is recommended to install sufficient number of fire extinguishers in all storage areas by 7th March, 2009.

Health and Safety: K. Personal Protective Equipment

H&S.11 Workers shall be provided with effective and all necessary personal protective equipment (such as gloves, eye protection, hearing protection, respiratory protection, etc.) to prevent unsafe exposure (such as inhalation or contact with solvent vapors, noise, dust, etc.) to health and safety hazards, including medical waste. (S)

Explanation: As regards guarding of machine-parts for safety, not all of the machines have been provided with needle guards and Perspex eye guards. Even where available, none of the workers are using these protective measures aptly. Although the factory has obtained a noise level certificate for different locations in the factory, the exact conditions while the readings were made were not documented. For instance at the time of the visit,

music was being played on the public address system. The noise levels because of the music played on this system added to the machine-running noise appears excessive.

Regarding PPE, -This being a unit that deals with knitted clothing there is excessive dust production. However, the workers are not using any masks. Only a few members use part of their clothing to cover their mouth and nose. - Rubber Mats have not been provided for workers in standing position.

Plan Of Action: Hanesbrands will ensure the factory to understand the importance & root cause of those safety issues; then we will monitor the factory to have safety devices on the machines, provide proper PPE to workers, adjust the noise level in production floor, not using public address system for playing music, provide rubber mats to standing workers and provide on-job training to their workers. We will have 1st follow up visit in January

Supplier CAP:

1. All machines will be inspected and be provided with needle guards and Perspex eye guards. On-job training is provided to machines operators on regular basis to ensure they use those safety devices.
2. Music will no longer be played through the public address system. The noise levels with the music will be measured again to ensure it is playing at comfortable sound level.
3. Factory will recheck the fitting of face masks to workers to ensure it is fit to their body. On-job training is provided to them on regular basis to ensure the awareness of PPE.
4. Rubber Mats will be provided to all workers who work in standing position.

Action Taken: Re-installed the needle guard and Perspex eye guards. See photo attachment. Hanesbrands auditor performed follow up visit on 2/26/2009: Needle guards and Perspex eye glasses are provided. A check has been done in cooperation with production personnel for all sewing machines, and found all the sewing machines are provided needle guards/ eye guards. Workers were found not using masks, and having talked to workers and management, it is understood that all the workers do not have mask. Management is advised to procure mask for each worker and to preserve at least 10% inventory to replace instantly if any worker damaged or lost his/her mask. Rubber mats are provided to standing workers.

Plan Of Action: Hanesbrands will ensure the factory posts the complete MSDS in the chemical usage area. Also, we will coach the factory how to train their workers by reviewing their training notes and evidences. Follow up visit will be done in January.
