**MEMORANDUM OF AGREEMENT**

**Date January 18, 2005**

The agreement entered into on January 1, 2002 by and between **Teamsters, Chauffeurs, Warehousemen & Helpers Local Union 182**, of Utica and Central New York, affiliated with the **International Brotherhood of Teamsters, AFL-CIO**, (hereinafter referred to as the **Local or Union**), and **The Town of Milford** (hereinafter referred the **“Employer or “Management”** or **“the Town”**) is hereby modified by and with the mutual consent of both parties.

**IT IS MUTUALLY AGREED:**

**1. Article 24 Wages and Classification – Section 24:01**

Effective January 1, 2005 the hourly wage classification of Motor Equipment Operators, Motor Equipment Operator and mechanic will be increased by twenty-five cents (\$.25). Effective January 1, 2006 increased by fifty cents (\$.50). Effective January 1, 2007 increased by fifty cents (\$.50) per hour.


January 1, 2005 \$12.00 per hour  
January 1, 2006 \$12.50 per hour  
January 1, 2007 \$13.00 per hour

**All other terms and conditions to remain the same.**

The agreement and the memorandum of agreement thereto shall continue in full force from the 1<sup>st</sup> day of January, 2005 to and including the 31<sup>st</sup> day of December 31, 2007 and thereafter from year to year unless altered or terminated the said three year period at the option of either party by giving at least sixty (60) day notice in writing to the other party to any such termination.
