WHEREAS, the Superintendent of Schools of the Attica Central School District (the "Board") and the Attica Central Administrators' Association (the "ACAA") are parties to a collective bargaining agreement effective July 1, 2005 through June 30, 2009, and

WHEREAS, the parties have agreed to extend the terms and conditions as set forth in that Agreement through June 30, 2011 except as specifically provided below;

NOW, IT IS HEREBY AGREED AS FOLLOWS:

1. The salary increase of 3.4% for the 2009-2010 school year will be in effect for the following individuals only:

John Spink, Asst. Principal – Sr. High School

The salary increase of 3.3% for the 2010-2011 school year will be effective for the entire unit stated in the recognition clause.
