

T LAST The Traveler greets you for the first time since October 1933, after almost a five-year odyssey from Ithaca. First he lingered with the Lotus-eaters "to dream and dream — to hear each other's whispered speech", until he almost lost remembrance of time and mission. Next he watched with anxious eyes the dreaded whirlpool of Vague-ybdis only to run afoul the snaky heads of Statis-cylla. As next he sailed amidst the flowery-kirtled Naiades, the loosened wax let in the silvery strains of Inertia-ypso. Then came Dawn the Rosy Fingered, released his prisoned soul, and sped him to his journey's end.

This *Traveler* is edited and financed by the Alumni Chapter. It will be published hereafter, probably annually and as before, by the Active Chapter with the support of the Alumni Chapter. It will be supplemented at regular intervals, as before, by newsletters, the next of which will appear early in October.

From necessity rather than from choice this edition is apparently a statistical edition of *The Traveler*. None of the items could have been omitted. All have been pared to essential facts. Five pages are devoted to the revised Constitution of the Corporation. Another five pages are given to thumbnail sketches of 41 members who have come into Acacia since 1933. In keeping with previous policy, these writeups are published in order that you may know more about your new Brothers than just their names. Writeups for men who were in-itiated this past school year have been omitted. Marriages, Births, and Deaths such as are known are given on page fourteen. A chapter roll of our 348 Actives and Alumni, together with their last known addresses, is given on pages fifteen to twenty. Every effort has been made to bring this list up to

#### RETROSPECT

The last *Traveler* was published while the Active Chapter was still living in the gloomy shaft perched on the hillside at "614". The amendments lifting the "dual tie" had just been passed and made a law of the National Fraternity.

In September 1934, the Active Chapter moved into its new permanent home at 318 Highland Avenue on Cayuga Heights. This new property was acquired by the Corporation for \$24,000. At the time of the purchase, a \$4,000 cash payment was made, leaving a first mortgage of \$20,000 upon which no payments were required for the first two years. Payments of \$500 on the mortgage have been made each of the past two school years, reducing present mortgage to \$19,000. For the first two years the interest on the mortgage was 3%; since then it has been 5%

During the last year at "614" the Actives were 12 in number. Since moving to their new home on the heights they have increased to an average of 30 or more (see page eight). The gloom of "614" and the absorption of grads in their advanced work has given way to the airy expanse of a big home full of boys.

#### YOUR OPPORTUNITY

Each graduation means the loss of members for the coming year, who must be replaced by incoming men. Any fellow recommended by two Masons is eligible to Acacia. Rent, house fees, and board average \$60 per month. Ascertain what "Acacia timber" from your community is planning to enter Cornell this fall, and send a penny postcard to Rufus J. Vail, 6 Homer Avenue., Cortland, N. Y. Do it at once.

The active Chapter is at present required to pay a yearly rental of \$2,000, half of which is interest and the mortgage. Practically nothing is left for upkeep and furnishings. Further mortgage liquidations is vital. This must depend upon initiation fees and payments on the building fund pledges. How does your pledge stand?

A news-letter (devoid of statistics) is promised for early October. Its size and success will depend upon the response of our 348 members. What's your contribution?

# Corporation Revises Constitution

The following Revised Constitution and By-Laws governing the Cornell Chapter of Acacia, Inc. (the Corporation) were adopted at the Annual Meeting held May 11, 1935.

The change in age of undergraduates due to the removal of the Masonic membership requirement made it necessary for the Corporation to adhere to the Membership Corporation Laws of the State by removing blanket membership of the Active Chapter members in the Corporation. It is necessary of course, that all members of the Corporation be twenty-one years of age.

The Articles of Incorporation were changed as required and also to permit the holding of real estate, by the Corporation, in Tompkins County instead of only in the City of Ithaca.

It was also apparent that many changes would have to be made in the existing Constitution and By-Laws. A committee, composed of W. W. Cotner, L. N. Simmons, and H. C. Reed, was appointed to make such changes as were found to be necessary. Their work eventually led to a complete revision, which was presented and adopted and is now spread before you.

#### CONSTITUTION

#### Article I-Name.

The name of this Corporation shall be "The Cornell Chapter of Acacia Fratenity, Inc." It shall be referred to, hereinafter, as "the Corporation."

#### Article II-Membership.

The membership of this Corporation shall consist of all the members of the Active Chapter who are of full age and are in good standing; all Alumni members of the Cornell Chapter who are of full age and are in good standing and all Honorary members of the Cornell Chapter who are of full age. The term "good standing" shall be interpreted as defined in the By-Laws of the Corporation.

#### Article III-Board of Directors.

Sec. 1—The property, affairs, business and concerns of the Corporation shall be vested in a Board of Directors consisting of seven (7) members.

Sec. 2-At the first annual meeting next held after the adoption of this Constitution; or if this Constitution is adopted at an annual meeting, then at that meeting; there shall be an election by written ballot for six (6) Directors to compose the Board of Directors of the Corporation. Two of the Directors shall be elected for the term of three (3) years; two shall be elected for the term of two (2) years and two shall be elected for the term of one (1) year. The Chapter advisor of the Active Chapter, if he shall be of full age, shall be ex-officio a member of the Board of Directors, and shall hold membership on the Board of Directors during his term of office as Chapter Advisor. At each annual meeting of the Corporation, thereafter, a number of Directors shall be elected equal to the number of Directors whose terms of office shall have expired and they shall hold office for the ensuing three (3) years or until their successors have been duly elected and qualified.

Sec. 3—The duties of the Board of Directors shall be those usually fulfilled by a Board of Directors and as may be specified by the By-Laws of this Constitution.

#### Article IV-Officers.

The officers of the Corporation shall be a President, a Vice-President, a Secretary and a Treasurer. They shall be elected by the Board of Directors as provided for in the By-Laws of this Constitution and shall hold office until their successors shall have been elected and properly qualified. At the pleasure of the Board of Directors the offices of Secretary and of Treasurer may be occupied by the same person.

#### Article V-Meetings.

Sec. 1—The annual meeting of the Corporation shall be held in the Chapter House on the last Saturday of April in each year and shall be convened at 7:30 o'clock in the evening.

Sec. 2—Special meetings of the Corporation shall be called as prescribed by the By-Laws.

Sec. 3—Regular meetings of the Board of Directors shall be held at the place and at the time set for such meetings by the Chairman of the Board of Directors. A regular meeting of the Board of Directors must be held during the first two weeks of the Fall semester of Cornell University and during the first two weeks of the Spring semester of Cornell University.

Sec. 4—Special meetings of the Board of Directors shall be held as specified by the By-Laws.

#### Article VI-Vacancies.

Vacancies in the Board of Directors and in the officers of the Corporation shall be filled as prescribed by the By-Laws.

#### Article VII-Voting and voting by proxy.

Sec. 1—The voting for the elective members of the Board of Directors shall be by written ballot and each office shall be voted upon separately.

Sec. 2—The voting upon any amendment to this Constitution, or upon any change in the By-Laws shall be by written ballot. Each amendment to the Constitution and/or change in the By-Laws shall be voted upon separately.

Sec. 3—The "yea" and "nay" vote of all written ballots shall be recorded, by totals, in the minutes of the meeting in which the vote is taken.

Sec. 4—The voting upon any and all other questions may be by written ballot or by

acclamation, at the discretion of the presiding officer or by action of the members of the Corporation present and voting at

such meetings.

Sec. 5—Absentee members of the Corporation may vote for the elective members of the Board of Directors and/or upon any proposed change or amendment to the Constitution and/or By-Laws by written proxy. The way and manner by which proxy votes be received, tallied and recorded shall be as prescribed in the By-Laws.

#### Article VIII-Quorum.

Sec. 1—A quorum for any meeting of the Corporation shall consist of not less than thirteen (13) members in good standing in the Corporation, one of whom must be an officer of the Corporation.

Sec. 2—A quorum for any meeting of the Board of Directors shall consist of not less than four (4) members of the Board, one of whom must be an officer of the Board

of Directors.

#### Article IX-Amendments.

Sec. 1—This Constitution may be amended at any annual meeting of the Corporation providing due and timely notice of such proposed amending be given to each and every member of the Corporation. Such notice of proposed amending to be given purusant to the provisions contained in the By-Laws.

Sec. 2—To amend this Constitution the written ballot shall show a two-thirds (%) majority vote of the members present, eligible to vote and voting; including the proxy votes of the members in good standing that shall have been received and duly qualified

for acceptance.

#### BY-LAWS

Article I-Membership.

Sec. 1—The term "good standing" used in the Constitution as applied to a member of the Active Chapter shall be interpreted to mean that the member is of full age, has paid all initiation fees, assessments of every kind, and all Active Chapter house fees, rentals, steward accounts and all other charges of any and every nature whatsoever and has signified his support of the Corporation by signing a pledge to the "Building Fund."

Sec. 2—The term "good standing" used in the Constitution as applied to an Alumnus of the Cornell Chapter of Acacia Fraternity shall be interpreted to mean that the Alumnus member has paid all indebitness of every nature whatsoever to the Active Chapter and is clear on the books of the Active Chapter; and has paid his pledge to the Building Fund in full or is making payment upon that pledge in accord with the terms thereof.

Sec. 3—All Honorary members of the Active Chapter who are of full age are in good standing in the Corporation without

further obligation on their parts.

Sec. 4—A member of the Active Chapter or an Alumnus member of the Active Chapter, being of full age, but who would not be in "good standing" under the terms of

sections number one (1) and two (2) of this article may be voted into "good standing" by the members in good standing present and voting at any meeting of the Corporation. Voting into "good standing" shall be by written ballot and shall require a majority vote of those present and voting. The minutes of the meeting shall show the name of the member or members voted into good standing and shall record the "yea" and nay" vote in each instance. Such voting into good standing shall be in effect for only the meeting in which it is voted and shall not be considered to have effect in perpetuity.

#### Article II-Duties of the Board of Directors.

Sec. 1—Immediately at the close of the annual meeting the retiring Chairman of the Board of Directors shall convene the new Board of Directors and shall proceed with the organization of the new Board. They shall, at that time, elect from among themselves a Chairman, a Vice-Chairman and a Secretary.

Sec. 2—When the Board of Directors shall have perfected its own permanent organization they shall proceed, immediately, to the election of a President, a Vice-President, a Secretary and a Treasurer for the

Corporation.

Sec. 3—At the pleasure of the Board of Directors the offices of Secretary and of Treasurer may be filled by the same person. All officers of the Corporation must be elected from the membership in good standing of the Corporation. If it is deemed expedient, and proper, by the Board of Directors they may elect the Secretary of the Board of Directors to be the Secretary-Treasurer of the Corporation.

Sec. 4—In the event that a quorum of the newly elected Board of Directors cannot be assembled at the close of an annual meeting the retiring Chairman of the retiring Board of Directors shall continue in office until he can call a special meeting of the new Board of Directors and effect its proper organization. He shall immediately issue a call to the newly elected Board of Directors to assemble at a specified time and place, within a period of not more than twenty (20) days after the annual meeting for the election of the proper officers and for the transaction of such other business as shall properly come before such meeting.

Sec. 5—The Board of Directors shall perform all the duties usually performed by a Board of Directors and shall perform such specific duties as may be required of them.

Sec. 6—The Board of Directors shall be the owners and administrators of all the physical properties, real estate and tangible assets of both the Active Chapter and of the Corporation of the Cornell Chapter of Acacia Fraternity.

They shall have the power to hold meetings at such time and at such place as they may deem proper; to appoint committees on particular subjects from the membership of the Board or from among other qualified members of the Corporation; to audit bulls

and disburse funds of the Corporation; to issue to all members of the Corporation from time to time reports as to the progress of the alfairs of the Corporation; to carry into execution such measures as they may deem proper and expedient to promote the welfare of the Active Chapter and of the Corporation and to protect the interests of the members of the Active Chapter and of the Corporation.

Sec. 7-The Chairman of the Board of Directors, by and with the advice of the Board, may appoint special committees on (a) Finance and (b) Housing; such committees to consist of not less than three (3) qualified members of the Corporation; to have the following specific duties:

#### Committee of Finance:

This committee shall, on or before the fifteenth (15th) day of the first month of the Fall semester, prepare a budget for the Corporation to cover all the disbursements on the part of the Corporation covering payments on all indebitness of principle, taxes, interest, maintenance, repairs of building and grounds, sinking fund and/or other such expense as shall from time to time be found necessary.

They shall confer with the Officers of the Active Chapter and/or such committee or committees as the Officers of the Active Chapter shall designate and shall arrange with them as to any and all payments on the part of the Active Chapter to the Corporation, and shall set the amount and terms of such payment.

And if so requested by the Active Chapter shall aid the Active Chapter in the formation of a balanced budget for the Active Chapter; shall assist the Active Chapter in securing the payment of delinquent accounts due it and in every way open to the Committee further the best financial interests of the Active Chapter.

#### Committee on Housing:

This committee shall interest itself in seeing that the Active Chapter is properly housed; that the furnishings of the Chapter House are adequate and in keeping with the dignity of the Fraternity; that proper care is taken of the real estate and building; that all proper maintenance and repairs are made to keep the investment unimpaired; shall confer, from time to time, with the Chapter Advisor and the Officers of the Active Chapter to the end that harmony may prevail and to receive suggestions as to the needs of the Active Chapter to properly further the interests of the Fraternity, and to see that such needs of the Active Chapter are supplied within the limits of the finances of the Corporation.

Sec. 8-The Board of Directors shall, within sixty (60) days after the annual meeting, publish or cause to be published a report of the affairs of the Corporation, together with a summary of the minutes of the annual meeting. This report shall be sent to all members of the Corporation

through the medium of a Chapter letter or publication, an Alumni letter or publication or by a direct letter from the Corporation to its members or by other such means as the Board of Directors may approve. Sec. 9—The Board of Directors shall de-

termine the ways and manners in which the Secretary and the Treasurer of the Corporation shall keep their respective records, and shall determine as to what manner and way be observed by the Treasurer in making disbursements.

#### Article III-Duties of Officers.

Sec. 1-Duties of the President.

The President shall preside over all meetings of the Corporation and shall perform all the duties usually ascribed to the office of President.

He shall perform the following specific duties:-

Issue, or cause to be issued, the call for the annual meeting and all special meetings of the Corporation in accordance with terms of the Article called "meetings" of these By-

In the absence or incapacity of the Chairman of the Board of Directors, or the failure of the Chairman of the Board to properly convene the Board, the President shall assume the duties of the Chairman of the Board until such itme as the Board shall have consummated its organization in conformity with the Constitution and By-Laws.

Sec. 2-Duties of the Vice-President.

The Vice-President shall, in the absence or incapacity of the President, fulfill all the duties of the President and shall perform all other duties naturally falling to the office of Vice-President.

Sec. 3-Duties of the Secretary.

The Secretary shall be the custodian of the Corporate seal and shall perform all the duties usual to the office of Secretary. He shall keep the records of the Corporation in permanent form according to the ways and manners that may from time to time be designated by the Board of Directors. He shall, specifically, cause a rollcall to be made at each Corporation meeting and record in the minutes of each meeting the names of all persons present at that meeting; making separate listing of the officers present, the members of the Board of Directors present, members of the Corporation present, members of the Active Chapter present, members of the Alumni Chapter present who are not members of the Corporation and the names of all others who may be present at a Corporation meeting upon proper invitation.

#### Sec. 4-Duties of the Treasurer:

He shall perform all the duties usual to the office of Treasurer. He shall receive all monies paid to the Corporation and shall deposit such monies to the credit of the Corporation in such depository as shall be designated by the Board of Directors. He shall make disbursements upon proper warrant from the Board of Directors and in such manner as the Board of Directors may

designate. He shall secure and properly file all receipts for monies disbursed. He shall be the custodian of the records of the "Building Fund" and the records of the pledges thereon, and shall keep these records in the way and manner designated by the Board of Directors.

Sec. 5-Bonding of the Treasurer.

The Treasurer of the Corporation shall be bonded at the expense of the Corporation and in an amount not less than the average cash holdings of the Corporation or in such larger amount as the Board of Directors may approve.

The bond shall be obtained from such bonding company or companies as the Board

of Directors may approve.

The bond, when duly signed and delivered, shall be held in the possession of

the President of the Corporation.

In no case shall the Board of Directors approve of the filing of personal bonds by the Treasurer, nor shall they approve of the filing of bonds on the behalf of the Treasurer by individuals or a group of individuals.

#### Article IV-Meetings.

Sec. 1—The President, or presiding officer, shall issue or cause to be issued a call for the annual meeting of the Corporation not less than fifteen (15) days nor more than thirty (30) days prior to the date of the meeting.

Sec. 2—The President, or presiding officer, shall issue or cause to be issued a call for special meetings of the Corporation not less than seven (7) days nor more than fifteen (15) days prior to the date of the meeting.

Sec. 3—The President, or presiding officer of the Corporation, or the Chairman of the Board of Directors must issue a call for a special meeting of the Corporation upon the written petition of ten (10) or more

members of the Corporation.

Sec. 4—Calls for special meetings of the Corporation shall state the reason for calling such special meeting and shall specify the business to be transacted at the special meeting. Only such business as has been stated in the call for a special meeting shall be transacted at that meeting.

Sec. 5—Calls to the annual meeting and calls to special meetings may be incorporated in any Active Chapter letter, pamphlet or communication; may be incorporated in Alumni Chapter letter, phamphlet or communication; or may be incorporated in any letter, pamphlet or communication from the Corporation or from the Board of Directors of the Corporation providing that such letter, pamphlet or communication be sent through the regular postal service and mailed to the last known address of every member of the Corporation, in conformity with all New York State laws governing notification of members of Membership Corporations.

Sec. 6—The Board of Directors shall hold stated meetings at the Chapter house on or before the fifteenth (15th) day of the first month of the Fall semester, each year, and on or before the fifteenth (15th) day of the first month of the Spring semester, each

year, and shall convene for special meetings at the call of the Chairman of the Board and/or of the Secretary of the Board. A special meeting of the Board of Directors must be called upon the written petition of three (3) or more members of the Board when such petition is presented to the Chairman of the Board or to the Secretary of the Board. Special meetings of the Board of Directors shall meet at the time and in the place designated in the call to the meeting.

#### Article V-Vacancies.

Sec. 1—Vacancies in the offices of the Corporation shall be filled in the following manner.

If the office of President shall be vacated for any reason the Vice-President shall immediately become the Acting-President and shall continue in office until the next annual meeting.

If the office of Vice-President, Secretary or Treasurer shall become vacant the Board of Directors shall, within thirty (30) days of the vacancy occurring, convene and by proper election fill the vacancy or vacancies.

Sec. 2—In the case of vacancies occurring in the Board of Directors and such vacancies number not more than three (3) the remaining Directors shall convene and by proper election chose from among the qualified members of the Corporation directors to fill the vacancies until the next annual election. At the next annual election, after any such vacancies occur, the Corporation shall elect Directors to serve the unexpired terms of the Directors whose position became vacant.

Sec. 3—In the case of vacancies in the Board of Directors when the vacancies shall number more than three (3) a special meeting of the Corporation shall be called for the purpose of electing the required number of Directors. At such special meeting for the election of Directors absentee members of the Corporation who are duly qualified to vote at Corporation meetings may vote for such Directors to be elected, by proxy as defined in Section 5, Article 7 of the Constitution.

#### Article VI-Amendments.

Amendments to or changes in these By-Laws may be made at any regular or special meeting of the Corporation on a majority vote of the members of the Corporation present, qualified to vote and voting, providing that such amendment to or change in the By-Laws as may be proposed has been sent to all the members of the Corporation with the call to the meeting.

#### Article VII-Voting by Proxy.

Sec. 1—Absentee members in good standing of the Corporation who would be entitled to vote at any meeting of the Corporation at which they were present may vote for the Directors and upon any proposed change and/or amendment to the Constitution and/or these By-Laws by written proxy.

Sec. 2-Said proxy to clearly indicate in an unequivocal way the wishes of the member so voting. All such proxies shall be addressed to the Secretary of the Corporation at the Chapter House, shall bear upon the envelope the phrase "Proxy Vote" and shall remain unopened until the Corporation is ready to vote upon the directors to be elected or upon the change and/or amendment proposed to the Constitution and/or By-Laws. At this time the President or Presiding Officer at the Corporation meeting shall appoint a Committee of three members of the Corporation who shall open, tabulate, count, record and report to the President or Presiding Officer upon the proxies received, and shall state the results of such proxy ballots.

Sec. 3—The results of the count of the proxy ballots shall be added to the ballots cast at the meeting for the Director and for or against the proposed change or amendment to the Constitution and By-Laws. And a separate entry in the minutes of the meeting shall show the name of the member voting by proxy, the name or names of the person or persons voted for and the "aye" or "nay" vote upon the amendment or change voted upon.

Article VIII—Special Committees.

Sec. 1—The President or Presiding Officer of the Corporation shall appoint not less than thirty days (30) nor more than fifty

(50) days before the annual meeting a nominating Committee who shall report in writing to the President or Presiding Officer nominations for the Board of Directors. The report of this Committee shall be included in the call to the Annual meeting.

Sec. 2—The President of Presiding Officer of the Corporation shall appoint not less than five (5) days not more than thirty (30) days before the Annual Meeting an Auditing Committee whose duty shall be to completely audit the books and accounts of the Treasurer and to certify them to the Corporation at the Annual Meeting. The Annual report of the Treasurer should be verified and signed by the members of the Auditing Committee and made a part of the minutes of the Annual Meeting.

Article IX-Nominations for Directors.

Sec. 1—At the Annual Meeting or at a Special Meeting of the Corporation when Directors are to be elected the President or Presiding Officer shall, at the time for the election, call for the report of the Nominating Committee which shall be then read and entered upon the minutes of the meeting.

Sec. 2—The President or Presiding Officer of the Corporation shall then call for any further nominations for the position of Director and shall not close the nominations until he is satisfied that no further nominations are to be made.

#### Article X-Rules of Order.

Roberts rules of order shall be considered the authority upon which all questions of order shall be decided.

Under the Old Constitution and By-Laws, the officers for 1934-35 were: R. R. Birch, Pres.; L. N. Simmons, Vice-Pres.; and G. F. Heuser, Secy-Treas.

With the adoption of the Revised Constitution and By-Laws, on May 11, 1935, the following Directors were elected: R. R. Birch and G. F. Heuser, for three-year terms; F. B. Morris and H. C. Reed, for two-year terms; and W. W. Cotner and the Venerable Dean of the Active Chapter, for one-year terms. Earl Sunderville, Chapter Advisor, became ex-officio a Director. The V.D.'s place was first filled by A. M. Con-

nelly; and subsequently by A. E. Jordan, J. R. Graham, and R. L. Rider the present V.D. Brother Morris declined re-election and was succeeded by Leland Spencer. The other Directors have been re-elected at the expiration of their terms.
