

# **Appendix D** — **Miscellaneous Items**

Donald Weadon, attorney *The Weston Forum*, May 1, 2008

Donald A. Weadon Jr. died March 23, 2008. He was 63.

Mr. Weadon was born in Brisbane, Australia, and grew up in Weston. He attended Hurlburt School and then graduated from the Loomis School in Windsor.

He received a degree in government in 1968 from Cornell University, where he sang in the Cornell Glee Club, managed the club's year-long world tour, and was the president of Delta Kappa Epsilon fraternity. He also served on the Cornell University Trustee Council.

Mr. Weadon received a degree from the University of California Hastings College of the Law in San Francisco in 1975 and a master's degree from the Harvard Business School Adjunct Program at the Iran Centre for Management Studies in Tehran in 1976.

In 1984, he opened a firm, Weadon and Associates, in Washington, although he occasionally joined larger firms interested in expanding their international trade portfolio. He was a consultant to international technology companies and the Commerce and Defense departments.

He opened law offices in Riyadh, Saudi Arabia; Beijing and Hanoi, and was the first attorney granted clearance by the U.S. Treasury Department to practice law in Vietnam. He also set up a foundation to support Vietnamese orphans.

Mr. Weadon was an adjunct professor of foreign trade law at George Mason University and Golden Gate University Law School and lectured at the Massachusetts Institute of Technology on international high-tech ventures.

He also contributed articles to scholarly journals, newspapers and blogs, often on issues involving Iran and the Middle East.

Survivors include his wife of 13 years, Suzanne Hayden Cameron Weadon of Washington, D.C., and his sister, Priscilla S. Weadon, a marketing consultant in Westport.

A new book on the 16 September 1920 incident that took the life of Brother Franklin G. Miller '21 was published this year: *The Day Wall Street Exploded* by Beverly Gage (Oxford: Oxford University Press, 2009). It was reviewed in the *New York Times Book Review* by Kevin Baker (Sunday, 22 February 2009, p. 12).

Excerpt, The Deke House at Cornell: A Concise History of the Delta Chi Chapter of Delta Kappa Epsilon, 1870-1930, p. 71.

On 16 September 1920, a substantial bomb secreted in a horse drawn wagon exploded in front of the J. P. Morgan Building located in New York's Wall Street district.<sup>3</sup> The blast was lethal: thirty-three were killed and some three hundred were injured. Brother Franklin G. Miller '21, by then employed by the Elliott-Fisher

Adding Machine Company, was among those slain. Back in Ithaca, the chapter was shocked and outraged. Somber resolutions were enacted and subsequently published in the *Delta Kappa Epsilon Quarterly*. The perpetrator of this misdeed was never identified despite the frenzied efforts of the FBI.

Brother Brian Merrick O'Connor reported the following item.<sup>7</sup>



I received my March/April 2009 Cornell Alumni Magazine a couple days ago, and read the cover story about the takeover of the Straight in April 1969. I noticed that the last picture in the article was of an unnamed student who was protesting the agreement reached between the faculty and the Afro-American Society. This student did indeed have a name; it's my old roommate from the Deke House, Frank Boyle Burnside, Jr. (originally Class of '72, but took his show on the road back to Wilkes-Barre, PA. He goes by "Mike" now.)

Today, I received the following email, saying the issue is online. If you want to check out the article, follow the link listed below, click on Cover Story, and then Burnside's picture is on the last page. Just think, we Dekes are part of a "History Lesson," which is the subtitle of the article. Between this and my quote (by name) in the *New* 

*York Times* during the April 1969 Thrash and Flail, we have placed ourselves as important arbiters of this pivotal time in the history of Cornell, and, indeed, the nation, or some such rot.

### Appendix E Minutes of the Meeting of the Board of Directors of the Delta Chi Association Held in Ithaca, New York, June 7, 2008

The meeting was called to order at 1:00 PM. Members present were:

The Treasurer's report was distributed and approved. Our Cornell accounts are in the red because of the boiler project followed closely by the replacement of the flitch plate beams in the dining room. Dale Williams has arranged a transfer of \$55,000 from the Jordan Lamb account plus a 7 year, \$50,000 loan which gives us about \$4000.00 in positive account balances. The loan will be paid off from House revenues. Treasurer's report is attached. (Secy's note – may be discrepancy here – see attached email from FTP to Dale Williams). The Delta Chi Association has a balance of \$20,500 in the checking account and \$30,000 in a CD. Dues have shown a positive rend, up to \$33,385 from 21,000 last year.

Minutes of the June 9, 2007 meeting were presented to those who had not received electronic copies, and approved. Reading was waived.

Acting Chairman and President Lin Davidson asked various members to participate in a rundown of the year's events and activities:

Bill Houck described the boiler project and decisions made over the past year – fast track (April, 2007) increase scope by creating new room, level floor, improved egress from party area, hot water by end of August '07, heat by early October.

Matt Hyland offered that the gas bill appears to have decreased.

George Nesterczuk described the problem of the dining room flitch plate beams and indicated that there is a similar beam holding up the library. It will be exposed and inspected this summer. The dining room repair turned out very well. Some of the ceiling panels (a central block of them) hiding the new steel are lower, but this is almost unnoticeable.

The University's proposed sidewalk construction was discussed. It appears that it will be acceptable and should not impact the Roosevelt trees. The front steps show evidence of shifting and signs of undermining. This could be a broken pipe allowing soil to drain away or storm water piping out. There will be future expense on this item.

Purchase and installation of new washers and driers is stalled. Models have been selected. These will be paid for out of house account now. Action may have been delayed by our account situation,

which was only resolved on June 6.

<u>Law School Garage Issue</u>. This past Parents' Weekend George, Lin and Frank met with the University Planner, Mina Admunsen. The basic trend seems to be that the University parking Authority is teaming up with various academic departments and inserting a garage into the lower stories of a new building, basically giving the user group a free foundation. The law School garage will contain three stories of parking plus law school floors and will be taller than the previous proposal, but recessed. There is a goal of preserving the view through the law School Arch, and hopefully this will benefit us also. The addition, per George, will rise from the upper parking lot rather than the lower, as previously proposed.

<u>Jay Grzyb – Scholarship Report</u>. Nine candidates were nominated, all good. It was agreed to submit all nine to the University

<u>Homecoming & Don Weadon Memorial</u>. George Nesterczuk read the inscription on the flitch plate beam:

"As these beams support the upper reaches of our lodge, so did Donald Alford Weadon, '67 sustain our brotherhood throughout his tenure as Chairman of the Board and President of the Delta Chi Association of Delta Kappa Epsilon, 1997 – 2008. Dedicated this day of June 7, 2008 by his grateful friends in DKE."

<u>Memorial Ideas</u>. George reported that Kent Hubbell suggested endowment of a fraternity/sorority assistant, for \$250 K.

Dedication of dining room;

Creation and dedication of chapter advisor endowment: cash flow of \$10K per year, of which \$2-3 K is stipend from Association, balance room and board value. Discussion on role of chapter advisor, how make sure he is engaged and looking out for issues that can severely impact the House.

Matt Hyland suggested a fund raiser in Don's name;

Dedication of a scholarship, such as Chairman's award: Frank stated that an endowment is not necessary. These funds are throwing off enough cash that the University, by law, will spend it if we don't.

Bill Fogle suggested that a Homecoming memorial service would be a good occasion on which to present an 1871 songbook (a very fine specimen) to the University.

Eric Neumann inquired about Suzie Weadon. George indicated that she would appreciate a plaque on the gong that was brought up from Don's effects. Eric will take care of the plaque and assembling a photograph and program signed by all the brothers who were in Washington on April 4. Lin suggested that area brothers call on her and inquire if she needs any assistance.

George Nesterczuk has obtained a large quantity (12 boxes) of documentary materials from Don's files. He will turn anything of historical interest over to Bill Fogle. Operational stuff will be turned over to Lin.

Matt suggested a point man for the memorial service. George will take this.

# Appendix F Report from Active Members Chris Bentley, Avi and Tom Hudson

Avi reported that TV is now secure via lockable cabinet. The audio system in the bar has been upgraded. Wood paneling has been installed in the weight room.

Upcoming "to do" items include the foyer tiles and the third floor and other toilets. Lin Davidson stated emphatically that the toilets are "unacceptable" and need to be a priority this summer.

Rush: 4 pledges in fall, plus 13 in spring. Spring retention was 10 for 13, with an 11<sup>th</sup> possibly returning (fall 2009) – left school.

Charities – Relay for Life, raised 17 K; also phoneathon, 15 K

Dryers: Make sure Martin Kelly acknowledges receipt of specs and okays.

**Disciplinary issues**: Spring 2008 culminated in a disciplinary hearing precipitated by an armed robbery in conjunction with alcohol violations and fire violations. Consequences were imposed. Matt Hyland asked for a summary of the University's disciplinary measures:

- 1) Disciplinary probation 2 years, expires spring 2010. Any (significant) infraction goes to a hearing board to evaluate shutting down the House. Has been appealed, requesting one year followed by evaluation to end or extend probation.
- 2) Social Probation 7 weeks, starting in fall semester; one social event is allowed. Two alcohol seminars and one fire seminar are required. A retreat is required by August 30.

A Code of conduct will be drafted by the actives and finalized, to be presented at September 6 retreat.

George will forward the letter of decision

### **Association Matters**

Nominations: Agreed, Lin Davidson will take over as chairman

George Nesterczuk proposed that the Board of Directors be expanded back to 15 members in order to spread the workload and achieve broader class representation. Recruiting will be needed.

Presentation of a bylaw amendment to the Association meeting was proposed by George, seconded and passed unanimously.

Nominees to be presented to the membership are:

Bob Platt recommended committees, with a non-board member for each decade, with the idea that these people would become board members. Discussed informal term limits.

Matt Hyland raised the question of forming standing committees, chaired by board members but staffed with non-members, such as Ritual, fundraising, finance, facility, University relations.

No bylaw change needed for this.

Bob Malatesta stated a need for personal contact between committee chair and its members.

George stated that we need help from the actives to turn down the heat. University related problems consume incredible time and energy.
