






Professor Martin,


The Master of Divinity

The four curricular areas integrate the three emphases found in our mission stat educate men and women, lay and ordained, for ministries that are "pastoral, lea prophetic." Pastoral theology (PT) emphasizes the "pastoral" arts. Christian Scri Christian Faith emphasize a learned approach to the study of the Bible and our t ethical and historical heritage. The emphasis on ministry in a multicultural and m world highlights the prophetic task of ministry in a new millennium.

Yet, at a deeper level, each one of the four curricular emphases is "pastoral, pro learned," for each curricular area is taught in an integrative way that blends the distinct emphases. To give an example, the study of Scripture is more than learn approach to the Christian Scriptures leads to a prophetic reading of the Hebrew Christian Scriptures. In turn, we teach Scripture in ways that emphasize its use work of the church.

Electives in the Curriculum

The Master of Divinity is divided between required courses and electives. Of the the curriculum, 16 are required and 10 are electives. Electives may be used to t denominational requirements, to pursue a concentration in a particular area of th or to pursue specific interests.

Quality - Reframing the Discussion

What makes for a learner-centered law school? And how can we tell?

News magazines rank law schools on everything from student LSAT scores and faculty-student ratios to library holdings and employment rates. Alumni, parents, and friends freely share personal experiences and anecdotes, while accrediting agencies and other groups focus on organizational arrangements and resources.

This kind of information reveals some useful things about law school quality, but it doesn't tell us much about what is most important to student learning - whether an institution's programs and practices are having the desired effect on students' activities, experiences, and outcomes.

What is the Law School Survey of Student Engagement?

- Tuition, 2008-2009: \$9,600
- One of 5 distance learning law schools registered with the California State Bar
- Has awarded 691 full JDs in 6 years
- 235 admitted to practice in California
- Six other states and DC have allowed Concord graduates to sit for their bar exams
