FINANCIAL AID AT CORNELL UNIVERSITY

INFORMATION in this Bulletin applies only to the undergraduate divisions of Cornell University in Ithaca; separate publications are available for students interested in the Medical College or the Cornell University-New York Hospital School of Nursing in New York City.¹ Fellowships and other forms of assistance available to graduate students are listed in the Announcement of the Graduate School.

This Bulletin is issued for the guidance of two groups: prospective students, their parents, and counselors; and students already in residence. Correspondence from and concerning prospective students should be addressed to the Director of Admissions, Administration Building, unless specific directions to the contrary are given in the following pages. Students in residence should consult the Office of Dean of Men and Dean of Women in the Administration Building, unless some other procedure is definitely prescribed.

SCHOLARSHIPS AND GRANTS-IN-AID

Many of the scholarships open to freshmen are awarded on the basis of competitive examinations. Prospective students should therefore study this Bulletin early in the final year of secondary school, in order to be certain that their applications are on file at the proper time and that they make the necessary arrangements to take the required tests. No award to a prospective student is considered final until he has been accepted for admission and has begun his studies. The applicant should therefore be careful to follow every prescribed step in the procedure outlined in the *General Information* booklet for admission to the school or college of the University in which he desires to enroll.

As indicated in the following pages, some scholarships and grants are open to all students in all divisions of the University. Others are limited to students in particular schools or colleges; to men or women only; to students who have attained sophomore, junior, or senior standing; to persons from specified geographic areas; and even, in a few instances, to special racial groups, such as Chinese or American Indians. In all cases, preference is given to matriculated students unless the

award is specifically designated as a freshman scholarship. Transfer students cannot compete for freshman scholarships, but are eligible for the other awards after being in residence at Cornell for at least one semester. The donors of a large number of the available funds have placed emphasis on financial need as well as academic achievement. Every applicant should therefore study the entire Bulletin carefully to determine what qualifications are demanded before submitting an application for a scholarship or grant. The deadline for applications is May 10, unless otherwise specified.

LOANS

Students who have successfully completed at least two terms in the University are eligible to apply for loans. (See page 34.)

PRIZES

Numerous prizes and special awards for achievement are listed in the pamphlet, *Prize Competitions*, which may be obtained at the Office of the Dean of Men and Dean of Women in the Administration Building, or by writing to Cornell University Official Publication, Administration Building, Cornell University, Ithaca, N. Y.

EMPLOYMENT

Many Cornell students augment their financial resources by seeking part-time employment during the academic year. Assistance in securing this type of work, as well as summer employment, is provided by the University through the Office of Dean of Men and Dean of Women. For details, see the *General Information* booklet.

GENERAL AWARDS

OPEN TO ENTERING FRESHMEN

CORNELL NATIONAL SCHOLARSHIPS. Open to men and women entering any undergraduate division. Annual award, free tuition and up to \$900. Tenure, the normal period of years required to obtain a Bachelor's Degree. At least 25 scholarships are awarded annually. Scholastic Aptitude Test of the College Entrance Examination Board required. Applicants must be of good character and personality and must be thoroughly qualified for academic success at Cornell University. Final selection will be based on capacity for scholastic achievement and on promise of effective participation and leadership in other University activities. Although financial need is not a factor in the selection of award winners, full consideration will be given to need (or lack of it) in fixing stipends, with free tuition the minimum award.

JOHN McMULLEN REGIONAL SCHOLARSHIPS. Open to men only, entering any of the several schools of the College of Engineering, who are not eligible for the New York State scholarships (see below). Annual award, up to \$600. Tenure, not limited. Up to 30 scholarships are awarded annually. Scholastic Aptitude Test of the College Entrance Examination Board required. Applicants must be of good character and personality and capable of creditable work in Engineering at Cornell University. Final selection will be based on scholastic achievement and general ability. Winners are chosen from 15 districts covering all of the United States except the State of New York.

GEORGE W. LeFEVRE SCHOLARSHIPS. (Gift under the will of George W. LeFevre '89.) Open to men and women entering any undergraduate division. Annual award, \$400. Tenure, not limited. Five scholarships are awarded annually. Scholastic Aptitude Test, Achievement Test in English composition, and any two other Achievement Tests of the College Entrance Examination Board required. Final selection will be based essentially upon the scores attained in the above tests, with financial need also considered.

UNIVERSITY UNDERGRADUATE SCHOLARSHIPS. Open to men and women entering any undergraduate division. Annual award, \$200. Tenure, first two years. Eighteen scholarships are awarded annually. Scholastic Aptitude Test, Achievement Test in English compo-

sition, and any two other Achievement Tests of the College Entrance Examination Board required. Final selection will be based essentially upon the scores attained in the above tests.

TO MAKE APPLICATION

Application material for any or all of the four scholarships described above may be obtained from Scholarship Secretary, Office of Admissions. Prospective candidates should write early in the senior year of secondary school, and in any case prior to February 15. The deadline for filing such applications is March 1 and none received after that date can be considered.

NEW YORK STATE AWARDS OPEN TO ENTERING FRESHMEN

STATE CORNELL SCHOLARSHIPS. Open to graduates of the common schools and academies of New York State. Annual award, \$200 reduction in tuition. Tenure, eight terms. Awarded by the Commissioner of Education, after a competitive examination. Apply to local high school principal, or to Commissioner of Education, Albany, New York. Students in residence who hold these scholarships should apply to the Secretary of the University for information.

STATE UNIVERSITY SCHOLARSHIPS. Open to graduates of the common schools and academies of New York State. Annual award, \$350. Tenure, eight terms. Awarded by the Commissioner of Education, after a competitive examination. Apply to local high school principal, or to Commissioner of Education, Albany, New York. Students in residence who hold these scholarships should apply to the Secretary of the University for information.

STATE WAR ORPHANS SCHOLARSHIPS. Open to graduates of the common schools and academies of New York State, who are children of deceased or disabled veterans of World War I. Annual award, \$350 toward tuition plus \$100 for maintenance. Tenure, eight terms. Awarded by the Commissioner of Education on the basis of Regents' examinations under regulations of the State Education Department. Apply to local high school principal or to Commissioner of Education, Albany, New York. Students in residence who hold these scholarships should apply for information to the Secretary of the University.

GENERAL SCHOLARSHIPS AND GRANTS-IN-AID ADMINISTERED BY UNIVERSITY COMMITTEES

(Preference given to students who have been in residence one year)

OPEN TO MEN AND WOMEN

DELLA S. BISHOP SCHOLARSHIP FUND. Open to regularly enrolled students in good standing who are certified by the President of the University as being worthy of financial assistance. Annual award, approximately \$200. Tenure, not limited.

CHARLES W. H. BLOOD SCHOLARSHIP. Open to deserving men and women students in the University. Annual award varies. Cash award. Tenure, not limited.

WILDEY B. AND ELLA H. COOPER MEMORIAL ENDOWMENT. Open to needy students from Rockland County and then to other students in need of financial aid. Annual award varies. Cash award. Tenure, not limited.

CORNELL ALUMNI CLUB SCHOLARSHIPS. Open to men and women, including freshmen. Annual awards vary. Cash awards. Tenure, usually four years. Awarded by the President of the University to candidates nominated by the Clubs. Application to be made to the president of the appropriate Cornell Club. Scholarships for the academic year 1949-1950 are being supported by the Cornell Clubs of Buffalo, Chicago, the Lehigh Valley, Maryland, New England, Mohawk Valley, New York, Philadelphia, Pittsburgh, Rochester, Syracuse, Nassau County, and Washington, D. C.

ALEXIS CRUTTENDEN MEDICAL SCHOLARSHIP. (Gift under the will of Mary Cruttenden Percy.) Open first to descendants of Alexis H. Cruttenden; second to graduates of Haverling High School, Bath, New York, who are residents of the town of Bath, New York, and who propose to take up the study of medicine; third to graduates of said school who are residents of Bath, New York. Annual award, \$200. Cash award. Tenure, not limited. Intelligence and financial need considered.

JOSIAH AND CAROLINE SMITH CURTIS SCHOLARSHIP FUND ENDOWMENT. Open to undergraduate men or women. Preference is always given to students from Town of Addison, Steuben

County, New York. Annual award, not to exceed \$200. Cash award. Tenure, not limited.

HARRY C. DAVIS COLORADO ENDOWMENT FUND. (Gift of Harry C. Davis.) Open to students from the state of Colorado. Annual award varies. Tenure, not limited. Income to be used annually to apply on the tuition and other expenses of a matriculated student, resident of the state of Colorado, excluding students receiving Federal aid or subsidy.

GENERAL SCHOLARSHIP FUND. Scholarships and grants from this fund are open to men and women, including freshmen. Annual awards vary. Cash awards. Tenure of scholarships is four or five years, but grants for shorter periods may be made to supplement other awards under the Alumni Club Scholarship program (above). Awarded by the President of the University.

CHARLES GREEN SCHOLARSHIP. Open to students in Mechanical or Electrical Engineering, Agriculture, or Architecture whose circumstances are such that they require assistance. Consideration will be given to mental, moral, and physical qualifications. Preference shall always be given to students from Schuylerville Union Free School. Annual award, \$200. Cash award. Tenure, not limited.

EUDORUS C. KENNY SCHOLARSHIP. (Gift of Eudorus C. Kenny, '82.) Open to men and women, including freshmen, with preference to the students from the Town of Truxton, New York. If scholarships are not filled by students from the Town of Truxton, vacancies will be filled by the Committee on Undergraduate Scholarships through examination. Annual award, \$250. Cash award. Tenure, four years. Apply to Principal of Truxton High School.

WALTER P. PHILLIPS SCHOLARSHIP FUND. Open to students from (1) the village of Fair Haven, New York (2) the Township of Sterling, Cayuga County, New York. Annual award \$200. Cash award. Tenure, unlimited unless there are other applicants.

THE PRESIDENT'S FUND. (Gift under the will of Dr. Veranus A. Moore, '87.) Open to men and women. Grants are made in the case of emergencies on the recommendation of the Committee on Student Aid.

CHARLES F. SMITH FUND. (Gift under the will of Charles F. Smith.) Open to students from the Town of Southhold, Suffolk County, New York, with preference usually given to upperclassmen. Annual award, usually \$50 to \$100. Cash award. Tenure, not limited.

HORACE I. SMITH FUND. (Gift under the will of Horace I. Smith.) Open to men and women, with preference to blood relatives of Horace

I. Smith and his wife and then to residents of Tompkins County, New York. Annual award, not to exceed \$100. Cash award. Tenure, not limited. Need and character considered.

STUDENT RELIEF FUND. A fund set up for the financial relief of needy students in emergencies, such as illness which involves a working student in heavy expense for hospitalization, doctors' bills, and loss of working time, for which the University's scholarship funds cannot be used and in which loan funds obviously cannot afford permanent relief.

EDWIN G. VAIL FUND. (Gift under the will of Edwin G. Vail.) Open to students from Dutchess County, New York. Annual award, \$400. Cash award. Tenure, not limited. Applicants are to be winners of State Tuition Scholarships from Dutchess County. Usually divided.

Sophomores, Juniors, and Seniors.

FRANCIS LEON CHRISMAN ENDOWMENT. (Gift under the will of Francis Leon Chrisman, '87.) Open to men and women, excluding freshmen. Annual award varies. Cash award. Tenure, not limited. For needy and promising students.

EDWARD CHANDLER DELANO SCHOLARSHIPS. (Gift under the will of Edward Chandler Delano in memory of his parents, Rufus Chandler and Almeda Matilda Delano.) Open to students from Wayne County, New York, who have been in attendance for one year. Annual award, \$100. Cash award. Tenure, not limited. Financial need and scholarship considered.

JEREMIAH W. AND REBECCA A. DWIGHT SCHOLARSHIP. (Gift under the will of Adelia A. Dwight in memory of her parents, Jeremiah W. and Rebecca A. Dwight.) Open to men and women, excluding freshmen, with preference for meritorious students from Dryden, New York, and if there be no students from said town, then to meritorious students residing in Tompkins County, New York. Annual award, \$280. Cash award. Tenure, not limited. Financial need considered.

G. HOWELL NORTH SCHOLARSHIP ENDOWMENT. (Gift under the will of Mrs. Mary A. North.) Open to men and women, excluding freshmen. Annual award varies. Cash award. Tenure, not limited. Merit and financial need considered.

LA VERNE NOYES SCHOLARSHIPS. (Gift from the La Verne Noyes Foundation, Chicago, Illinois.) Open to descendants by blood of veterans of World War I, whose discharge was under honorable conditions. Where enlistment was made after May 11, 1918, applications

will not be considered unless active overseas pre-armistice service was rendered. Scholarships may not be awarded for use in the freshman year. Annual minimum award, \$100 toward tuition. Tenure, not limited.

SCHOLARSHIP HOLDERS FUND. (Gift of Dr. G. S. Graves, '05 and L. Carrol Root, '92.) Open to men and women, excluding freshmen. Annual award varies. Tenure, not limited. Merit and financial need considered.

Juniors and Seniors.

MARY RICHARD ANTHONY SCHOLARSHIP. (Gift under the will of Marjorie R. Anthony.) Open to students who have attained junior class standing. Annual award, approximately \$100. Cash award. Tenure, not limited. One awarded each year. Preference to a student from the town of Springport, Cayuga County, New York.

DR. LOUIS ALEXANDER DREYFUS MEMORIAL SCHOLARSHIPS. (Gift of Mrs. Alexander Dreyfus in memory of her husband.) Open to junior and senior men and women, with preference first to graduates of public schools in Richmond County, New York; second to graduates of schools in Fremont, Sandusky County, Ohio; third to other applicants from Sandusky County, Ohio. Preferably to one man and one woman. Annual award, \$500. Cash award. Tenure, not limited. Two scholarships are available each year. Need and personal qualifications considered.

OPEN TO WOMEN

DeWITT BEAHAN ENDOWMENT. (Gift under the will of Bessie DeWitt Beahan.) Open to women. Annual value, varies; not more than \$200. Tenure, not limited. Apply to: Office of Dean of Men and Dean of Women. Eligibility determined by academic standing and need.

FEDERATION SCHOLARSHIPS. (Supported by the Federation of Cornell Women's Clubs.) Open to women, including freshmen. Annual award, \$400. Tenure, one year; privilege of renewal upon application and on vote of Awards Committee. Awarded on the basis of ability, academic standing, health, and financial need. Deadline date for new applications and renewals, March 1, 1950. Applications should be addressed to: Mrs. H. E. Shackelton, 914 East State Street, Ithaca, New York.

HAVILAND SCHOLARSHIP. (Gift under the wills of John G. Haviland and Bernice Haviland Guernsey.) Open to women residing in Warren County, New York. Annual award, \$150. Cash award. Tenure,

one year; may be renewed. Academic proficiency and financial need considered.

NETTIE A. STANTON SCHOLARSHIP. (Gift under the will of Nettie A. Stanton.) Open to deserving young women of Cornell. Annual award, approximately \$150. Cash award. Tenure, not limited.

TOWN OF SPENCER SCHOLARSHIP. (Gift of Miss Mary F. Hall.) Open to women, with preference first to applicants from Spencer, New York, and then to students from Tioga and adjacent counties. Annual award, approximately \$150. Cash award. Tenure, not limited.

Juniors and Seniors.

MABEL ESTEY ROSE SCHOLARSHIP. (Gift under the will of Mabel Estey Rose.) Open to women, with preference for juniors and seniors of direct New England descent. Awarded on the basis of character, scholarship, and need. Annual award, approximately \$300. Tenure, one year. Entering transfers, apply as for Federation scholarships (above). Resident students, apply to Office of Dean of Men and Dean of Women.

Seniors.

IDA H. HYDE SCHOLARSHIP. (Gift of Dr. Ida H. Hyde, '91) Open to senior women majoring in science, with preference for those who intend to continue in the scientific field and who have been largely self-supporting. Annual award, \$100. Tenure, one year. Applications should be made to the Office of Dean of Men and Dean of Women.

LAURA OSBORN MEMORIAL FUND. (Gift under the will of Mrs. Isabella G. King.) Open to senior women. Annual award, \$100. Cash award. Tenure, one year. Three or four awarded annually. Awards made on recommendation of the Dean of Women to students with better than average scholastic standing and demonstrated financial need.

OPEN TO MEN

HENRY ARTHUR GAERTNER SCHOLARSHIP ENDOWMENT. Open to any deserving and meritorious young man of New York State. Annual award, \$100. Cash award. Tenure, not limited. Financial need and academic achievement considered. Preference given to enrolled students.

JOHN KNICKERBACKER FUND. (Gift of John Knickerbacker, 1887.) Open to men students in Cornell who lack means for adequate support. Persons declared eligible may borrow up to \$600 a year, one

half of the amount borrowed to be repaid at 2% interest beginning two years after graduation or after leaving the University, one third of principal to be paid within five years and the remainder within ten years after graduation or leaving the University. Recipients must have good minds, sound moral opinions and beliefs, be earnest and persevering workers, and come from parents known to be or to have been good citizens, both of whom were born in the United States.

ALBERT C. MURPHY SCHOLARSHIPS. (Gift under the will of Albert C. Murphy.) Open to male students with preference to those entering from the city of East St. Louis, Illinois. Annual award, \$1600. Cash award. Tenure, not limited. Awarded on the basis of competitive examination. Apply to Principal of High Schools in East St. Louis, Illinois.

STEWART L. WOODFORD MEMORIAL ENDOWMENT. Open to needy and deserving men students. Annual award, not to exceed \$120. Cash award. Tenure, not limited.

ADDITIONAL INFORMATION

Students in financial need who are interested in any of the above scholarships or grants may obtain additional information from the Office of Dean of Men and Dean of Women, unless otherwise indicated.

SCHOLARSHIPS ADMINISTERED BY INDIVIDUAL COLLEGES, SCHOOLS, AND DEPARTMENTS OF THE UNIVERSITY

(Various scholarships are available to students in each of the schools and colleges of the University. There are a few scholarships for entering freshmen but most are reserved for students who have been regularly enrolled in the particular school or college for at least one year.)

THE NEW YORK STATE COLLEGE OF AGRICULTURE

OPEN TO MEN AND WOMEN

CARL E. LADD MEMORIAL SCHOLARSHIPS. Open to all students in Agriculture. Annual award, \$200. Tenure, not limited. Fourteen scholarships. Awarded to farm boys and girls on the basis of need, promise of future leadership in agriculture, and academic achievement.

NON-RESIDENT TUITION SCHOLARSHIPS. Open to students who are not residents of New York State. One of the purposes of these scholarships is to assist students from foreign countries, but where no qualified foreign students are available, they may be extended to any qualified out-of-state students. Annual award, \$300 applicable to tuition only. Tenure, not limited. Fifteen scholarships. Need and academic achievement considered.

Freshmen.

GEORGE LaMONT SCHOLARSHIP. (Gift of G. B. LaMont and T. E. LaMont.) Open to freshmen entering from farms in Orleans County. Annual award, approximately \$200. Tenure, one year. Need and scholarship considered. Apply to: Teacher of Vocational Agriculture in local High School or to Secretary of the College of Agriculture.

HARRISON L. BEATTY AGRICULTURAL SCHOLARSHIP. (Gift under the will of Harrison L. Beatty.) Open to entering freshmen who are residents of Chenango County. Annual award, approximately \$200. Tenure, one year. Awarded to applicant with highest Regents average. Apply to Principal of any high school in Chenango County.

Sophomores, Juniors, and Seniors.

ROBERT M. ADAMS 4-H MEMORIAL SCHOLARSHIP. (Established by the 4-H Club Organization as a memorial to Robert M. Adams.) Open to undergraduates, except freshmen, who are residents of New York State, with preference to 4-H Club members. Annual award, \$50. Tenure, not limited. Need and scholarship considered.

HERVEY S. HALL SCHOLARSHIP. (Gift of Miss Mary F. Hall in honor of her father.) Open to sophomores, juniors, and seniors, with preference to applicants from the Town of Spencer; then to applicants from Tioga County. Annual award, approximately \$120. Tenure, not limited. Need and scholarship considered.

CHARLES H. ROBERTS SCHOLARSHIPS. (Gift of Charles H. Roberts.) Open to sophomores, juniors, and seniors with reference to those from rural districts. Annual award, approximately \$250. Tenure, one year. Five scholarships. Scholarship and need considered.

Juniors and Seniors

A. R. BRAND SCHOLARSHIP IN ORNITHOLOGY. Open to any junior, senior, or graduate student specializing in ornithology who has demonstrated ability and initiative. Annual award, approximately \$300. Tenure, not limited. One or more scholarships. Need is considered.

OPEN TO WOMEN

MRS. FRANCIS KING SCHOLARSHIP. (Gift of the New York State Division of the Woman's National Farm and Garden Association.) Open to a woman student entering or already enrolled. Annual award, \$150. Tenure, two years. Character, scholarship, financial need, and activities considered.

Juniors and Seniors.

MRS. WALTER DOUGLAS SCHOLARSHIP. (Gift of the New York State Division of the Woman's National Farm and Garden Association.) Open to a junior or senior woman who has achieved a high standing in Agriculture and related studies, with preference to a 4-H Club member. Annual award, \$150. Tenure, one or two years. Character and financial need considered.

OPEN TO MEN

ESSO 4-H SCHOLARSHIPS. (Established by the Standard Oil Company of New Jersey.) Open to boys who have satisfactorily completed at least three years of 4-H Club work including the preceding year, and

who graduate from high school with a scholastic standing in the upper half of their class. Annual award, \$100. Tenure, 4 years provided the holder remains in college and maintains a satisfactory record. Apply to 4-H Club agent in each county. Applications must be on file in the Office of Resident Instruction, Roberts Hall, Ithaca, New York, by July 15.

WARD W. STEVENS HOLSTEIN SCHOLARSHIP. (Gift of Holstein-Friesian Association in honor of Ward W. Stevens.) Open to male student who has completed at least one-half of his course. Annual award of \$500 may be divided between two students. Tenure not limited. Awarded on basis of exceptional ability in judging and handling of dairy cattle, high scholastic rank in dairy husbandry courses, special interest in the Holstein breed of cattle, and need.

Freshmen.

NEW YORK STATE BANKERS ASSOCIATION SCHOLARSHIP. Open to men students entering the College of Agriculture, who are members of 4-H Clubs in New York State. Annual award, \$200. Tenure, one year. Need, scholarship, and 4-H Club activities considered. Apply to local 4-H Club Agent.

SEARS-ROEBUCK AGRICULTURAL FOUNDATION SCHOLARSHIPS. Open to freshmen men coming from farms in New York State. Annual award, usually \$200. Tenure, one year. Number of scholarships variable. Need and scholarship considered.

THE COLLEGE OF ARCHITECTURE

OPEN TO MEN AND WOMEN

UNDERGRADUATE SCHOLARSHIPS. Open to all students including entering students. Annual award, tuition. Tenure, not limited. Four scholarships. Awarded on the basis of financial need and professional promise. Entering students apply to the Director of Admissions.

Fourth and Fifth Year Students.

GILLESPIE PRIZE SCHOLARSHIPS. (Gift of Albert D. Gillespie.) Open to fourth or fifth year students. Annual award, \$400. Tenure, one or two years. Two scholarships. Awarded on the basis of general academic performance and need.

Graduates.

paid by its members and from funds given for the purpose by individual alumni or groups of alumni. These Scholarships will be awarded in the discretion of the Faculty under rules prescribed by the Law Association.

GEORGE W. HOYT FUND. This fund came to the University under the will of George W. Hoyt, A.B. '96. Following Mr. Hoyt's wish that the income be used for the benefit of the Law School, the Board of Trustees voted that for the present this income be appropriated for scholarships in the Law School. Approximately \$2000 will be annually available for this purpose.

THE DICKSON RANDOLPH KNOTT MEMORIAL. This memorial was established by Mrs. Sophia Dickson Knott in honor of her son, First Lieutenant Dickson Randolph Knott, AUS. Lieutenant Knott, ranking student in the law class of 1944 at the end of its first year, wearer of the Purple Heart and the Silver Star, was killed in action in Italy, October 22, 1943. The income from the memorial will be devoted to aid classmates of Lieutenant Knott upon their return to Law School, or other veterans in the School.

LEONARD T. MILLIMAN COOPERATIVE LAW SCHOLARSHIP. This is the gift of Mr. and Mrs. Thomas E. Milliman in memory of their son, Ensign Leonard T. Milliman, USN. Its value is three hundred dollars and it is open to a student in the Law School who has an agricultural background and who is a potential specialist in the field of farmer-producer cooperative law.

CUTHBERT W. POUND FUND. This memorial was created through contributions made in memory of the late Cuthbert W. Pound, '87, Chief Judge of the New York Court of Appeals and one time member of the Faculty of the Cornell Law School.

HENRY W. SACKETT SCHOLARSHIPS. Two scholarships have been established for the year 1949-1950, from the Sackett Law School Endowment Fund. These scholarships are to be awarded in the discretion of the Law Faculty.

MYNDERSE VAN CLEEF SCHOLARSHIP. This scholarship, of the value of seventy-five dollars, is awarded in the discretion of the Law Faculty.

JOHN JAMES VAN NOSTRAND SCHOLARSHIPS. Two scholarships, available to students, after the first year, are awarded on the basis of financial need, character, and scholarship.

THE NEW YORK STATE VETERINARY COLLEGE

OPEN TO MEN AND WOMEN

NON-RESIDENT TUITION SCHOLARSHIPS. Four scholarships. Open to undergraduate students who are not residents of New York State. Annual award, waiver of tuition. Need and academic achievement considered. Tenure, subject to annual review and dependent upon satisfactory scholastic progress.

Seniors.

BORDEN SCHOLARSHIP AWARD. Open to seniors. Annual award, \$300. Awarded by the Dean of the Veterinary College to the eligible student who has achieved the highest average grade in the veterinary curriculum preceding the senior year.

VALENTINE MOTT KNAPP SCHOLARSHIP. Open to students who have completed three years of work. Annual award, \$400. Cash award. Tenure, one year. Applications must be filed before June 1. Applicants must have demonstrated ability to do creditable work. Consideration also given to personal characteristics of applicant, with respect to professional attitude and financial need.

THE CORNELL UNIVERSITY-NEW YORK HOSPITAL SCHOOL OF NURSING

FUND OF THE COMMITTEE FOR SCHOLARSHIPS OF THE CORNELL UNIVERSITY-NEW YORK HOSPITAL SCHOOL OF NURSING. (Fund maintained by a committee of laywomen interested in the School of Nursing.) Open to students entering the School of Nursing and to students in any one of the three years. All students applying for admission are considered, but students especially interested are encouraged to so indicate in their applications for admission. Awarded on the basis of all-round good record as indicated by academic work, participation in school and community activities, special abilities and personal qualities indicating promise. Apply to the Dean of the Cornell University-New York Hospital School of Nursing, 525 East 68th Street, New York City.

SCHOLARSHIPS FOR FOREIGN STUDENTS

FOREIGN STUDENT SCHOLARSHIPS. Open to either graduate or undergraduate students from foreign countries. Annual award, tuition, according to the college or school in which registered. Twenty-four scholarships available. Tenure not limited. Awarded by the President of the University after review of credentials and recommendation by the proper officials. Need and academic promise considered.

S. K. ALFRED SZE FUND. (The gift of John L. Senior, '08, a classmate of Mr. Sze.) Open to Chinese students. Annual award varies. Cash award. Tenure, not limited. Financial need and character considered.

WILLARD STRAIGHT MEMORIAL FUND. (Established by the Class of 1901 as a memorial to Willard Straight, '01.) Annual award varies. Income to be used in aiding Chinese students in securing an education. Financial need and character considered.

TO MAKE APPLICATION

Applications for the above scholarships should be made to the Counselor of Foreign Students, Administration Building, Ithaca, New York.

In addition to the above scholarships foreign students are eligible for the Out-of-State undergraduate tuition scholarships in all the New York State schools and colleges at Cornell University (see above), and the various scholarships and fellowships administered by the Graduate School and open to all graduate students. For the former the application should be submitted to the Counselor of Foreign Students who will transmit it to the proper officials in the state school or college. For the latter, which are listed in the Announcement of the Graduate School, application should be made directly to the Dean of the Graduate School, Administration Building, Ithaca, New York.

SCHOLARSHIPS FOR VETERANS

STATE WAR SERVICE SCHOLARSHIPS FOR VETERANS. Under the laws of 1945, 1946, 1947, 1948, and 1949, New York State has awarded 1200 scholarships each year to veterans who were legal residents of New York State at induction into the armed forces, who are

now legal residents of New York State and who hold an honorable discharge. Annual award, \$350. Tenure, four years. Holders were chosen by competitive examination and the scholarships were distributed geographically within the state. Whether these scholarships will be awarded in the next and succeeding years depends upon the Legislature. OLIVE WHITMAN MEMORIAL SCHOLARSHIP FUND. (Made possible through the D. A. R.) Open to American Indian women of New York State who are studying or are planning to study in the N. Y. ANNIE M. HATCH INDIAN SCHOLARSHIP. (Gift under the will of Annie M. Hatch.) Open to New York State Indians with preference to those who intend to enter the College of Agriculture. The scholarship is awarded by the Committee on Student Aid in conjunction with the scholarship committee of the college in which the applicant wishes to enroll.

LOANS

Loans to promising students in need of assistance have been made possible by many gifts to the University. It is a general policy to grant such loans only to students who have completed at least two terms at Cornell.

The student in need of assistance should apply first to the dean or director of the school or college in which he is enrolled. If funds are not available from that source, he may apply for aid from one of the general loan funds through the Office of the Dean of Men and Dean of Women.

Approval of requests for loans is based on such factors as financial need, personal reliability, and academic progress.

Money borrowed from Endowment or University funds is to be repaid, with interest at 4%. Said interest starts when the student leaves Cornell, unless otherwise provided by the terms of the Endowment, at a time agreed upon between the borrower and the Treasurer. The borrower gives a note as security; collateral security is not required. The University has adopted certain rules which experience has shown to be necessary to ensure that these funds shall accomplish a maximum of effectual help to deserving students. These rules impose certain restrictions upon the Committee's disposition of the funds. Among the restrictions are these:

1. A student is eligible to borrow from this source only after maintaining a satisfactory standing in classes and in other respects during a residence of at least one year in the University.
2. A loan is not ordinarily made to enable a student to meet the expenses of the Summer Session.
3. A student cannot borrow more than \$300 in any one year, and not more than \$600 during his or her time in residence.
