

# **Women Veterinarians Co-owning Veterinary Practices**

One of the common models for co-owning veterinary practices involves a married couple. While some may regard this management model as having developed in the last couple of decades as gender parity was reached and surpassed in veterinary classes, it was also actually quite common in the first half of the 20<sup>th</sup> century.

I was reminded of the legacy of this co-ownership model last week while reading the obituary of Dr. Henry Doremus, a 1946 Cornell graduate. He and his wife, Dr. Helen (Borchmann) Doremus '40 jointly established two small animal practices. They initially built the Doremus Animal Hospital in Cedar Grove, New Jersey and 12 years later relocated to Vermont and opened the Green Mountain Animal Hospital in South Burlington.

Hank and Helen were not unique. Five of the nine women who graduated from Cornell between 1939 and 1942 co-owned practices with their spouses. The other couples were:

- Drs. Patricia (O'Connor) '39 and John Halloran '40, in Staten Island, New York.
- Drs. Emily (Chickering) '40 and Henry Polanski '41, in Lancaster, Massachusetts.

- Drs. Margaret (O'Brien) '40 and Clarence Combs '39, in Shrewsbury, New Jersey.
- Drs. Grace (Kinney) '42 and Ralph Loomis '40, in Warsaw, New York.

Among those who did not marry veterinarians, one woman from this period owned a practice in Connecticut, then moved to St. Thomas and became the "Veterinarian-in-Charge" in the Virgin Islands. Two others were practice associates; and one became an academician.

Sometimes we think of women as owning practices only in the modern era, but many of those who graduated 75 years ago were trailblazers in business as well as medicine.
