MEMORANDUM OF AGREEMENT
BETWEEN THE
GENESEE VALLEY CENTRAL SCHOOL DISTRICT
AND THE
GENESEE VALLEY EDUCATORS ASSOCIATION

In accordance with Board Resolution dated 11/25/2010 and by this agreement between the Genesee Valley Central School District (District") and the Genesee Valley Educators Association ("Association"), agree to the following:

1. The parties agree to amend the duration of the current contract that was initially effective July 1, 2005 through June 30, 2010 for two (2) additional years through June 30, 2012.

As such, Article I. Section 100: Duration shall be amended as follows:

This agreement made and entered into on July 1, 2010, by and between the Chief Executive Officer of the Genesee Valley Central School, hereafter referred to as the "Superintendent" and the Genesee Valley Educators' Association, hereafter referred to as the "Association", shall remain in force through June 30, 2012.

2. Increases will be as follows:

- a. Increase to base salary, inclusive of increment, and to coaching/extra-curricular pay schedule:

2010-11	4.00%
2011-12	3.75%

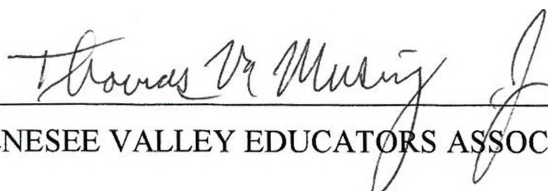
3. Nothing in this agreement shall establish a past practice or precedent. No other aspects present or future of the bargaining agreement are affected by this agreement.
