January 18, 2007

The parties' representatives agree to continue all terms and conditions of employment set forth in the 2003-2005 collective bargaining agreement between the Floral Park-Bellerose Union Free School District and the Civil Service Employees Association, Local 1000, AFSCUE, AFL-CIO (Nurses' Unit), except as expressly amended herein:

1. **Term:** Three (3) years 2006-2007; 2007-2008; 2008-2009.

2. **Salary Increase:**

Salary schedule shall be increased as follows:


2006-07	3.5%
