## **EQUIPMENT REQUIREMENTS**

The MS-Windows version of the FOLIO VIP software requires MS-Windows (3.0 or higher). The software itself requires approximately 2 MB of hard disk space; the associated help files, another 2 MB. Most of the titles are comfortably under 1 MB (exceptions -- Federal Rules of Civil Procedure and Comments, 1.2 MB and the UCC, 3.4 MB in its entirety but broken into separate files, one for each article).

The DOS version of the FOLIO VIP software requires 4 MB of ram to run satisfactorily. Its disk-space demands are: 4 MB without the files necessary to print and 6.6 MB with those files.

## **ORDERING INDIVIDUAL TITLES**

The charge for an individual license for the VIP software and any one title is \$20. There is an additional shipping and handling charge of \$7 for each order. Those who have a licensed copy of the full-featured FOLIO Views software (e.g., participants in the LEXIS-NEXIS Student Office Software program) can order titles without the VIP software, at an individual fee of \$15 per title, plus shipping and handling. To order one or more titles fill out the attached form and sent it to the Legal Information Institute via fax, mail or e-mail. Phone orders are also accepted.
