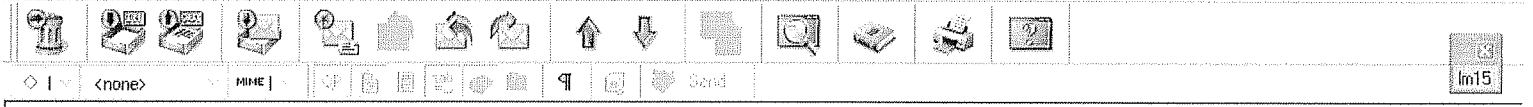

now withdrawn from the local collection because they are held in a "shared" remote storage facility starting with volumes that have been transferred during fiscal year 2005-06. Exclude volumes held collectively because they are held by other organizations such as the Center of Research Libraries (CRL) that are supported by membership dues and determination on whether to maintain membership may vary from year to year.
