Christopher R. Duncan is an Assistant Professor in the Department of Religious Studies and the School for Global Studies at Arizona State University. He has been conducting anthropological research in North Maluku since 1994, including research on the Forest Tobelo and on the 1999-2000 conflict and forced migration. He is currently working on a comparative study of rural-rural migration in Vietnam and Halmahera.
