INSTRUCTIONS FOR CONTRIBUTORS

Medieval Philosophy and Theology is a semi-annual, peer-reviewed journal devoted to the publication of original articles in all areas of medieval philosophy, including logic and natural science, and in medieval theology, including Christian, Jewish, and Islamic. Coverage extends from the Patristic period through the neoscholasticism of the seventeenth century. Members of the Editorial Board and the panel of Editorial Advisors represent eleven different countries in Europe and North America, as well as a wide range of academic, disciplinary, and scholarly traditions and approaches. The journal is published in English but will consider manuscripts submitted in French, German, and Italian.

Preparation of manuscript. A separate title page should be prepared including the article title, short title for use as a running head (not to exceed 45 characters), author's full name and affiliation, and complete contact information (including phone number and email address). Manuscripts should be submitted in triplicate and should conform to *Chicago Style*. Please include a diskette version of the manuscript; the disk and the hard copy versions should match perfectly. Disk submissions should be made in Word or WordPerfect for Macintosh or IBM-compatible computers. The entire manuscript, including references, should be typed double-spaced on 8-1/2 x 11 inch or A4 paper, with wide margins for copyediting. Notes and references should be typed on a separate sheet. *Medieval Philosophy and Theology* is published in English but will consider manuscripts submitted in French, German, and Italian.

Copyediting and proofreading. The publisher reserves the right to copyedit and proofread all articles accepted for publication, but authors will be consulted in the case of any substantial changes. Page proofs of each article will be sent to the lead author.

General. Submitting an article to *Medieval Philosophy and Theology* implies that it has not been published elsewhere. Authors must obtain written permission to publish any material for which they do not own copyright. They will be asked to assign the copyright of their article, under certain conditions, to Cambridge University Press. Authors of articles will receive 25 offprints of their article free of charge; additional copies may be purchased if ordered at proof stage on the form provided. (In the case of joint contributions, offprints will be sent to the first named author unless otherwise requested.)

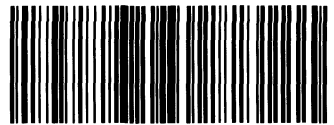
