

Warning Concerning Copyright Restrictions

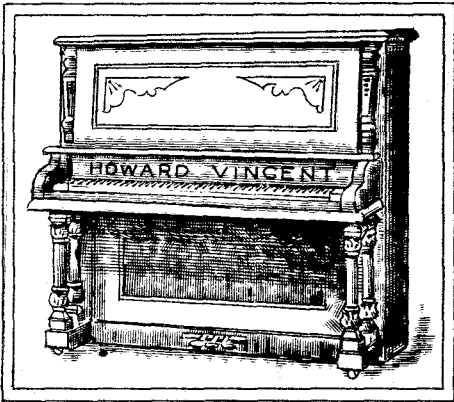
The copyright law of the United States (Title 17, United States Code) governs the making of photocopies or other reproductions of copyrighted material.

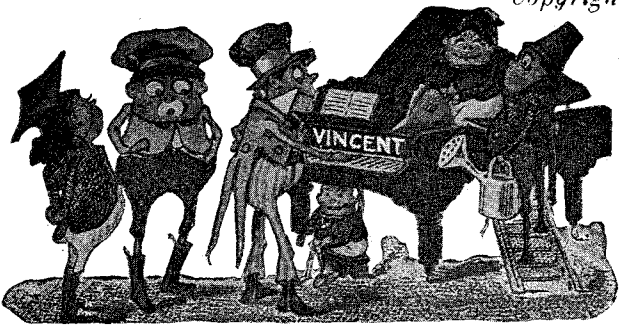


