**Memorandum of Agreement
between
Harpurville Teachers' Association
and the
Harpurville Central School District**

Re: Contract 2009-2010

The following is tentatively agreed to as an extension of the 2006-2009 Collective Bargaining Agreement between the parties. It is understood that final agreement is dependent on ratification by the Association and the approval of the District Board of Education.

1. For the period of July 1, 2009 to June 30, 2010, each bargaining unit member shall receive an increase of 4% on (as attached):

Base salary
Graduate hours
Masters degree

2. All other terms of the Collective Bargaining Agreement will remain unchanged and all other terms and conditions of the existing contract will remain in effect for the 2009-2010 contract year.

SCOPE OF AGREEMENT D

1. The period during which this contract is in effect is July 1, 2009 to June 30, 2010.

3. Masters degrees shall be compensated at \$1,975 in 2009-10.
